### NCPO Workshop Assistance Program

The Workshop Assistance Program is an award program established by NCPO to assist its members in attending and participating in NCPO sponsored workshops and the annual ABA Client Protection Forum. The workshop assistance award will be evaluated based upon financial need. The maximum award to be granted is \$1,000 for each event. The award recipient will also receive a waiver of the registration fee to the NCPO workshop. Factors to be considered by NCPO in awarding workshop assistance may include, but not be limited to:

- assets of the organization;
- operating budget for the organization;
- inability to obtain approval by the governing body for attendance at the workshop or similar conferences;
- prior attendance at NCPO workshops;
- •length of time applicant has held the position indicated on the application;
- •individual's or organization's prior award of workshop assistance; and
- •circumstances forming the basis of the organization's inability to fully pay for the applicant's attendance at the workshop.

#### Do you know where your annual report is?

Does your fund issue an annual report? If not, 2025 is the perfect year to start! Annual reports provide your court, the bar and public with up-to-date information on claims paid, resources available, operational expenses, subrogation received and a host of other data crucial to your fund's mission. They are also excellent source documents to produce when challenges arise. Changes in assessments, other funding issues, proposals to implement loss prevention mechanisms such as payee notification and more can all be effectively addressed by the information in your annual report.

#### On the Docket – Your NCPO at work

Your NCPO is a busy advocate for client protection across the U.S. and Canada. Here's an overview of some current initiatives.

- NCPO's Northeast Regional Vice President, Linda Bauer, has opened the lines of communication with the American Immigration Lawyers' Association to address the growing number of claims involving immigration lawyers and their clients. These particularly vulnerable clients may suffer losses which are not compensable because they arise in a State in which the respondent attorney is not admitted to the State bar, but can still represent clients before federal immigration courts. The concept of a "federal fund" has been suggested before, but its time may have come, given the large immigration case backlog and the potential for growing numbers of claims.
- NCPO is working towards the establishment of new funds in American territories, including the U.S. Virgin Islands, Guam and the Mariana Islands, and Puerto Rico. The process is ongoing to enlist the support of local courts and bar associations to bring client protection to these important areas.
- Although there are no funds in Mexico, good relations with our southern neighbors is critical. NCPO is working to engage with Mexican attorneys through the U.S. Mexico Bar Association. We have much to learn from each other and share the common interest of protecting clients and the integrity of the practice of law.
- From North America's oldest fund in Vermont to the few remaining U.S. states and Canadian provinces which have not yet joined the NCPO family, NCPO's outreach group "works the phones" to stay in touch and identify areas in which NCPO help will make the difference. Initiatives may be eligible for NCPO grants, and proposals are always welcome.

### Nominations Open for 2025 Isaac Hecht Award





The Hecht Award is granted annually to recognize an individual, law client protection fund, or other professional organization that has demonstrated excellence in the field of law client protection.

NCPO will also once again present the Issac Hecht Award as part of the 2025 Workshop program. Named in honor of one of NCPO's founders and its first (and long-time) treasurer, the Isaac Hecht award honors the memory of one of NCPO's co-founders, who practiced law in Maryland for 64 years before his death in 2003 at the age of 89. Mr. Hecht also served as Treasurer of Maryland's Fund since its creation in 1967. He was committed to the belief that the trust of law clients is the essential linchpin in every lawyerclient relationship, and that the reimbursement of innocent victims of lawyer dishonesty represents the legal profession at its best. Mr. Hecht was especially focused on the financial foundations of client protection funds, the initiatives of fund leaders, and their receptivity to techniques to deter and detect dishonest conduct in the practice of law.
